## Extension Tuition

### **HOURS AND DAYS**

The Extension Program is available after school from 3:15pm (2:15pm on Thursdays) to 6:00pm. The Extension Program operates only on regular school days and teacher in-service days, and is not available on holidays, vacations, or in the summer months (except during summer school).

### **MINIMUM DAYS**

The Extension Program is available on minimum days from 12:15pm to 6:00pm for children enrolled at St. John Vianney. Minimum days are included in monthly rates. Children must bring lunches on minimum days.

### **MONTHLY PAYMENT PLAN**

The monthly payment plan is designed for families who know they will be using the Extended Care Program on a regular basis. Rates are significantly lower than the drop-in rate and require a ten-month contractual commitment. Rates are calculated using 180 academic days, and payments are prorated over 10 months (July through April). Credit is not offered for unused days, absences, or on days that the Extended Care Program is closed. Monthly contracts are handled through FACTS Financial and billed at the end of each month. There is a \$150 per student Extended Care Program Registration Fee, which will be billed in July or upon registering for Extension. If a family on a monthly contract exceeds their pick-up time that they signed up for, they will be billed the drop-in rate (billed in one hour increments).

## **Extension Tuition and Payment Options for 2025-2026**

### **Annual Rate for 1 Student**

Pick-up by 4:00pm: \$1,400 (\$140 per month)

Pick-up by 5:00pm: \$2,650 (\$265 per month)

Pick-up by 6:00pm: \$3,400 (\$340 per month)

### **Annual Rate for 2+ Students**

Pick-up by 4:00pm: \$2,450 (\$245 per month)

Pick-up by 5:00pm: \$4,900 (\$490 per month)

Pick-up by 6:00pm: \$6,000 (\$600 per month)

### **DROP-IN RATE**

Students who are not on a monthly Extended Care Program contract will be charged the drop-in rate, billed in one hour increments, on a monthly basis. Drop-in Extended Care Program fees will be billed through FACTS Financial on the last day of the month, with funds being pulled approximately 10 days later. Families who opt into the drop-in plan will not be billed a \$150 per student extended care program registration fee. Drop-in fees will be calculated in the following manner:

\$5 (1 min-15 min)

\$10 (16 min-30 min)

\$15 (31 min-45 min)

\$20 (46 min-60 min)

## **EXTENSION FEES**

Extension Registration Fee \$150 per student (non-refundable)

Extension Drop-In Rate \$20 per student per hour (billed in one hour increments)

Extension Late Fee \$2 per minute (billed for picking up after 6:00pm)

Extension Level Change Fee \$25 per change (non-refundable)

Extension No Sign Out Fee (\$15 per child)

- Please note that our electronic system will assume that students not signed out of the program have stayed until closing time. Therefore, students not signed out will be billed the \$15 No Sign Out Fee + drop-in until 6pm.

Extension tuition will be billed over 10 months, with all payments beginning in July and ending in April. Extension tuition is automatically deducted through FACTS Tuition Management from a bank account of your choice. All Extension payments are processed through FACTS, and are typically deducted at the same time as tuition payments.

## **EXTENSION PICK-UP POLICY**

Parents and guardians must keep emergency contacts up to date in the FACTS Family Portal. If your student needs to go home with another family in an emergency situation, please write an email to the Extension Director. Students can not be released to somebody else without proper documentation.

## **HOW TO ENROLL**

Returning families with students who are currently enrolled will be automatically re-enrolled at the same level unless the Extension Director is otherwise notified by July 1, 2025. New families who want to enroll in the Extension Program will respond to a Google Survey that will be available in June. All Extension payments are processed through FACTS, and are typically deducted at the same time as tuition payments.
